The Mayor invited everyone to join him in the Pledge of Allegiance.

Upon motion made by Kimberley Payne, seconded by Ted Necarsulmer and unanimously carried, the Minutes of Regular Meeting held on March 15, 2019 and Budget Public Hearing held on April 1, 2019 were approved.

Local Law No. 2 of 2019

A Local Law Amending Chapter 123 (Peace and Good Order) by adding a new Article VIII regarding Peddling and by renumbering the existing Article VIII (Penalties for Offenses)

Section 1. The Board of Trustees hereby finds and determines that in order to enhance the safety of residents and prevent disturbances in the Village, there should be imposed a licensing requirement on place to place sales activities in the Village.

Section 2. Chapter 123 (Peace and Good Order) of the Village Code is hereby amended by adding a new Article VIII thereto to read in its entirety as follows:

Article VIII: Peddling

§ 123-21 Definitions

As uses in this Article, the following terms shall have the meanings indicated:

EXEMPT PERSON

A bona fide charitable, civic, educational, or similar not-for-profit organization and individuals working on behalf of such organization.

PEDDLING

Selling, offering for sale or soliciting offers to purchase goods or services of any kind or description by means of traveling by foot, motor vehicle or other means of conveyance from house to house, place to place or street to street.

PERSON

Any individual, corporation, partnership or other entity.

TOWN

The Town of Southampton, New York.

§ 123-22 License Required

A person, other than an exempt person, shall be permitted to engage in peddling in the Village of Quogue only if such person possesses and displays on demand of any Village police officer or code enforcement officer a valid peddler's license issued by the Town pursuant to Chapter 254 of the Southampton Town Code and, if a motor vehicle is used, a vehicle license card issued pursuant to such Chapter and displayed on such vehicle as required therein. Failure to comply with such requirements shall constitute an offense hereunder.

§ 123-23 Other Restrictions

- A. No loudspeakers, horns, bells or other noisemaking device may be used by any person engaged in peddling in the Village of Quogue.
- B. Nothing herein shall reduce or modify the obligation of any person engaged in peddling to comply with all parking and other traffic regulations. Nor may any peddling occur in any location where it would result in any congestion or public safety hazard, as determined by any police officer of the Village of Quogue.
- C. Any person engaged in peddling in the Village of Quogue must possess all other licenses and permits required to engage in such person's business, including, if food is sold, a valid license to handle food issued by the Suffolk County Department of Health.
- D. There shall be no peddling permitted at any park or recreation area of the Village of Quogue without the express permission of the Board of Trustees.
- E. Nothing in this Article shall be construed to permit peddling on the property of any person who communicates an objection thereto either directly to the person engaged in peddling or by posting a "no soliciting" or similar sign, and any person engaged in peddling shall obey such a direction.
- F. Any failure to comply with the foregoing restrictions shall constitute an offense hereunder.
 - Section 3. The existing Article VIII of Chapter 123 and existing Section 123-21 (Penalties for Offenses) shall be renumbered as Article IX and Section 123-24, respectively.

Section 4. This local law shall become effective 30 days after the filing thereof with the Secretary of State of the State of New York.

Upon motion made Jeanette Obser, seconded by Randy Cardo and unanimously carried, it was RESOLVED, "Local Law No. ____ of 2019 A Local Law Amending Chapter 123 (Peace and Good Order) by adding a new a new Section Prohibiting Transfers of Trash between Vehicles on any Road was introduced and a public hearing is scheduled to be held on Friday, May17, 2019 at 4:00 PM.

Local Law No. of 2019

A Local Law Amending Chapter 123 (Peace and Good Order) By adding a new Section Prohibiting Transfers of Trash between Vehicles on any Road

Section 1. The Board of Trustees hereby finds and determines that trash collection companies have been engaged in transferring trash from one collection vehicle to another on roads in the Village of Quogue and that such activity threatens to spill waste on the streets with attendant harmful effects on the environment and impair the welfare, prosperity and the peace and quiet of inhabitants, and therefore such activity should be prohibited.

Section 2. Chapter 123 of the Village Code is hereby amended by adding a new Section 123-3.1, which shall read in its entirety as follows:

§ 123-3.1 Trash Vehicle Transfers

No person engaged in the business of collection of trash shall transfer any collected trash from one collection vehicle to another vehicle on any public or private road in the Village of Quogue.

Section 3. This local law shall become effective 30 days after the filing thereof with the Secretary of State of the State of New York.

Upon motion made by Kimberley Payne, seconded by Jeanette Obser and unanimously carried, it was RESOLVED, "Local Law No. ____ of 2019 A Local Law Amending Chapter 111 (Noise) of the Village Code In Relation to Hours of Operation for Trash Collection was introduced and a Public Hearing is scheduled to be held on Friday, May 17, 2019.

Local Law No. of 2019

A Local Law Amending Chapter 111
(Noise) of the Village Code
In Relation to Hours of Operation for
Trash Collection

Section 1. The Board of Trustees hereby finds and determines that trash collection creates significant noise from the operation of collection vehicles and from the loading of trash

containers into collection vehicles and therefore the hours of operation for such activity should be limited in order to better secure and promote the public health, comfort and the peace and quiet of the Village of Quogue and its inhabitants.

Section 2. Section 111-4 (Violating Acts) is hereby amended by modifying Paragraph I (Loading and Unloading) so that it reads in its entirety as follows:

"Trash collection; loading or unloading. The collection of trash from any commercial or residential property other than between the hours of 7:00 a.m. and 6:00 p.m. or the creation of loud and excessive noise in connection with loading or unloading any vehicle or the opening and destruction of bales, boxes, crates and containers"

Section 3. This local law shall become effective upon the filing thereof with the Secretary of State of the State of New York.

With no other business to discuss, Mayor Sartorius moved that the Board adjourn into executive session for discussion of employee matters. Such motion was unanimously approved and the Board went into executive session at 5:06 P.M..

In executive session, the Board and the Village Attorney discussed the open Lieutenant position in the Police Department following interviews by the Board earlier in the afternoon with Sergeants Dan Bennett, Dan Hartman and Jason McMunn. After discussion, Chief Isola was called and invited to join the meeting. At the end of a further discussion, the Board dismissed Chief Isola and unanimously determined to appoint Dan Hartman as Lieutenant with the effective date to be determined by the Mayor in consultation with the Chief of Police. The executive session was terminated at 5:53 P.M., and upon motion made unanimously, seconded and passed, the meeting of the Board of Trustees was adjourned.
