The Mayor recited the Pledge of Allegiance.

Upon motion made by Ted Necarsulmer, seconded by Kimberley Payne and unanimously carried, the Minutes of Regular Meeting held on October 16, 2020 are approved.

Sidewalk work on Quogue Street and paving on Beach Lane and Assups Neck Lane will commence next week.

The Mayor stated that he had asked Chris Osborne to compile a list of the unsightly utility poles in the Village. After speaking with a Verizon representative, it appears the conditions of the poles will be addressed.

The Mayor addressed the Board regarding Dave Celi's interest in constructing an indoor sports facility on a lot in the light industry district on Industrial Drive. Mr. Celi would need a Special Exception approval from the Board of Trustees before going before the Zoning Board of Appeals and Planning Board. After a discussion including benefits to the community, parking and size of the complex, the Board decided to cautiously accept the idea and will seek more detailed information from Mr. Celi in order to determine if he should pursue the project.

Mayor Sartorius stated that there have been a few issues over the last year regarding houses being used as rental facilities exclusively which does not reflect the character of the community.

He asked the Board for their opinions on setting limitations on the number of rentals allowed per year. Wayne Bruyn has an article from the New York Law Journal regarding regulating short term rentals including case law. Limits would need to be reasonable and ascertainable. The article will be forwarded to board members and a draft of an amendment to the law will be on the December meeting agenda.

Eileen Duffy had questions regarding the indoor sports facility and comments regarding rentals. Mayor Sartorius requested Aimee Buhl compile a list of approved rentals since September 2020.

Lynn Joyce asked the Board if there is a specific requirement for property owners to install geocubes and what is the process. Mayor Sartorius and Bill Nowak answered that it requires Village and DEC approval. The property address in question, 160 Dune Road, does have a permit in place. Lynn stated that she is concerned by the way sand on the property is being dug. Bill Nowak will visit the property on Saturday.

With no other business to discuss and upon motion made by Ted Necarsulmer, seconded by Kimberley Payne and unanimously carried, the meeting was adjourned at 5:10 P.M.
