Upon motion made by Randy Cardo, seconded by Ted Necarsulmer and unanimously carried, it was RESOLVED, that Ian Fitzgerald is appointed to the position of Village Prosecutor, at a rate of \$250 per hour, effective January 1, 2022.

Upon motion made by Ted Necarsulmer, seconded by Randy Cardo and unanimously carried, it was RESOLVED, that Deanna Miller is appointed to the position of Office Assistant, at a yearly salary of \$40,000, effective January 10, 2022.

Upon motion made by Randy Cardo, seconded by Ted Necarsulmer and unanimously carried, it was RESOLVED, that a new Civil Service Position- Court Officer PT is created.

Upon motion made by Ted Necarsulmer, seconded by Randy Cardo and unanimously carried, it was RESOLVED, that Juan C. Regueiro is appointed to the position of Court Officer, at a rate of \$26 per hour, effective January 3, 2022, pending a background check.

Upon motion made by Ted Necarsulmer, seconded by Randy Cardo and unanimously carried, it was RESOLVED, that a reimbursement to Southampton Township Wildfowl Association (Quogue Wildlife Refuge) in the amount of \$5,000 for the labor and materials to replace the roof at 5 Old Country Road (Village-owned residence) is approved.

Upon motion made by Ted Necarsulmer, seconded by Randy Cardo and unanimously carried, it was RESOLVED, that an amendment to the 2021-2022 budget A3389 Public Safety and A3120450 Police/Maintenance Contracts in the amount of \$2,000, which represents a Lexipol subscription grant award, is approved.

Upon motion made by Randy Cardo, seconded by Ted Necarsulmer and unanimously carried, it was RESOLVED, that Change Order No. 1 from South Fork Asphalt, the contractor for the Jessup Avenue Reconstruction Project, in the amount of \$11,996.31, reflecting various additional quantities of material, as recommended by the Village Engineer, is accepted making the revised contract price \$749,995.91.

Upon motion made by Randy Cardo, seconded by Ted Necarsulmer and unanimously carried, it was RESOLVED, that the proposal from MJM Electric Corp. for a 24KW Generac generator for 121 Jessup Avenue in the amount of \$16,397 is accepted.

Upon motion made by Ted Necarsulmer, seconded by Randy Cardo and unanimously carried, it was RESOLVED, that Lynda Confessore, Sally McGrath, Paul Mejean and Barbara Sartorius are designated as 2021 persons of the year in appreciation of successfully overseeing the major renovation and expansion of the Quogue Library. The Mayor read the attached resolution honoring these individuals.

Incorporated Village of Quogue

WHEREAS, in December 2018, after years of planning, designing and fundraising, the Quogue Library formally broke ground on construction of a major renovation and expansion of its building at 90 Quogue Street; and

WHEREAS, the ambitious project included among other things a near-doubling of the size of the building from 5,500 square feet to more than 9,000, an innovation laboratory and technology center, a young adults room, an expanded children's room, a second floor addition for office and conference space, upgraded technology throughout the building, and reorganization of the beautiful grounds and incorporation of enhanced access to and use of them, all while retaining and incorporating the original 1897 library; and

WHEREAS, the project was overseen by the Library's all-volunteer Construction Committee, composed of Lynda Confessore, Sally McGrath, Paul Mejean and Barbara Sartorius; and

WHEREAS, each of the members of the Construction Committee was heavily involved with the planning and implementation of many details of the project, meeting at least weekly over several years with the architects, Austin Patterson Disston, and the general contractor, Sea Level Construction, and spending countless hours on site and coordinating with suppliers and subcontractors; and

WHEREAS, after construction was delayed by the effects of the Covid-19 pandemic, the Library completed the project, moved out of its temporary quarters on Midland Street and held a grand opening of the expanded and renovated building on June 26, 2021 with celebratory speeches, refreshments and tours; and

WHEREAS, the new building is a spectacular addition to the Village of Quogue and been greeted with rave reviews by its residents; and

WHEREAS, none of these improvements would have been possible without the enormous efforts of the members of the Construction Committee;

NOW, THEREFORE, BE IT RESOLVED that the Board of Trustees of the Village of Quogue expresses its deep appreciation to Lynda Confessore, Sally McGrath, Paul Mejean and Barbara Sartorius and hereby designates them as **2021 PERSONS OF THE YEAR**.
