



Request For An Updated or Pre-Existing Certificate of Occupancy Instructions

An Updated Certificate of Occupancy is required as per §196 of the Code of the Village of Quogue. In order to obtain an Updated Certificate of Occupancy for a parcel the following items must be provided or accomplished.

- 1. An up to date as built original sealed survey.
- 2. An up to date electric certificate of compliance for pool equipment.
- 3. Copies of all Certificates of Occupancy/Compliance and ZBA decisions for the parcel. (If you do not have them in your possession, you should file a Freedom of Information Law (FOIL) request with the Village office and review the building files for the property. They may be there.)
- 4. If there is a recent change in ownership, a copy of the deed must be submitted. Be aware that the C of O will be issued in the name of the current owner.
- 5. Any open building permits *must* be renewed, if necessary, and finalized prior to issuance of the updated C of O.
- 6. The correct house number must be displayed as per local and State Code.
- 7. Complete the form titled Request for an Updated or Pre-Existing Certificate of Occupancy.
- 8. If the request is for a preexisting use, a signed notarized affidavit regarding the history of the property will be required.
- 9. Submit the required \$250 fee with the application.
- 10. Submit a signed notarized smoke and carbon monoxide alarm affidavit. If hard wired detectors were not originally installed, battery operated detectors are acceptable.

3)	That carbon monoxide alarms devices are installed as per Section 73.1 of the Quogue Village Code adopting New York State Fire Code, which requires one for every floor of living space in the structure within 15' of rooms used for sleeping.
