MINUTES FOR THE REGULAR MEETING OF THE BOARD OF TRUSTEES OF THE VILLAGE OF QUOGUE, HELD ON FRIDAY, MARCH 21, 2025.

This meeting was accessible via Zoom.

The Mayor invited everyone to join him in the Pledge of Allegiance.

Upon motion made by Sally Beatty, seconded by Tom Mullen and unanimously carried, the Minutes of the Regular Meeting held on February 14, 2025 were approved.

Upon motion made by Sally Beatty, seconded by Tom Mullen and unanimously carried, it was RESOLVED that the Abstract of Audited Vouchers Schedule 03-25, \$366,978.84 and Treasurer's Report for the Month ending February 2025 are approved:

The Clerk gave the report for February 2025 False Fire and Burglar Alarms:

Fire Chief Dave Schaffauer gave the February 2025 report for the Fire Department. Police Chief Chris Isola gave the February 2025 report for the Police Department. Building Inspector William Nowak gave the February 2025 report for the Building Department.

Trustee Cardo recused himself from participating in the public hearing.

The Mayor opened the public hearing entitled: "A Local Law Amending §196-15.2E(2) (Minimum Site Size) and §196-15.2H (Dimensional Regulations) to grant the Board of Trustees authority under certain conditions to approve a Planned Retirement Community District on a site with less than 160,000 sq.ft. of lot area and to modify applicable dimensional regulations as introduced at the Board of Trustees meeting held on February 14, 2025 at 4:00 PM. The Mayor explained that the purpose of the proposed local law is to give the trustees greater flexibility than what the current 2005 local law allows. The Mayor explained that there are not many four acre lots available and that there is a growing need for smaller housing for the aging demographic. The Mayor stated that the Board had received six or seven letters in support of the initiative. The Mayor then asked for comments. Bob Murray, a Corcoran realtor, stated that he was in full support of the proposed local law and agrees that there is a strong need and demand for these homes. Irwin Messer inquired of the number of homes that could be built on a four-acre lot. The Mayor explained that the minimum size of the homes is 1,000 square feet and that up to four homes

could be built on a one-acre lot, meaning 16 homes on a four-acre lot. Sally Booth asked if this local law would pertain to all of Quogue. Village Attorney Wayne Bruyn stated that the A-1, A-2 and A-8 districts would be excluded. The Mayor stated that none of this is "of right"; the law would simply give the trustees greater flexibility in light of the increasing demand of smaller homes if a development were considered to be appropriate for the neighborhood. Kittric Motz commented on the granting procedure. The Mayor asked for Mrs. Lewis' comments, but since she was having Zoom microphone issues, the Mayor stated that he would reach out to her after the meeting and that he is aware she is in favor of the proposed local law.

Attorney Wayne Bruyn stated for the record that the board received a letter dated March 12, 2025 from the Suffolk County Planning Commission indicating that this local law is a matter of local determination and that a full environmental assessment form prepared by the Raynor Group was received.

Upon motion made by Tom Mullen, seconded by Sally Beatty and unanimously carried, the public hearing was closed.

WHEREAS, the Board of Trustees of the Village of Quogue have proposed a local law amending §196-15.2E(2) (Minimum Site Size) and §196-15.2H (Dimensional Regulations) to grant the Board of Trustees authority under certain conditions to approve a Planned Retirement Community District on a site with less than 160,000 sq.ft. of lot area and to modify applicable dimensional regulations (the "Local Law"); and

WHEREAS, the adoption of the proposed Local Law is subject to environmental review pursuant to Article 8 (State Environmental Quality Review Act -SEQRA) of the New York State Environmental Conservation Law and Chapter 87 (Environmental Quality Review) of the Code of the Village of Quogue and the adoption of the Local Law meets the criteria for classification as a "Type I Action" pursuant thereto; and

WHEREAS, by letter dated March 12, 2025, the Suffolk County Planning Commission considered the proposed Local Law to be a matter for local determination; and

WHEREAS, there are no other involved agencies requiring coordinated review; and

WHEREAS, a public hearing was held on March 21, 2025; and

WHEREAS, the proposed Local Law was referred to the Village's consulting planners and engineers for review to identify the potential impacts to the environment; and

WHEREAS, the Board of Trustees has conducted a review of the reference materials and information recorded in the Environmental Assessment Form Part I and the Environmental Assessment Form Parts II and III prepared by the Village consulting planners and engineers; and

WHEREAS, the magnitude and importance of each impact has been considered and the Board of Trustees finds that the adoption of the proposed Local Law will not result in any large and important impact(s) and, therefore, will not have a significant adverse impact on the environment.

NOW, THEREFORE BE IT RESOLVED, that pursuant to the 6 NYCRR §617.6, SEQR and Chapter 87 of the Code of the Village of Quogue, the Board of Trustees hereby assumes LEAD AGENCY status in connection with the adoption of the proposed Local Law; and

BE IT FURTHER RESOLVED, that pursuant to the 6 NYCRR §617.7, SEQR and Chapter 87 of the Code of the Village of Quogue, a NEGATIVE DECLARATION is hereby adopted for the proposed Local Law; and

BE IT FURTHER RESOLVED, that the Village is directed to deliver a copy of this resolution to the Suffolk County Planning Commission and all interested agencies.

WHEREAS, Board of Trustees of the Village of Quogue have proposed a local law amending §196-15.2E(2) (Minimum Site Size) and §196-15.2H (Dimensional Regulations) to grant the Board of Trustees authority under certain conditions to approve a Planned Retirement Community District on a site with less than 160,000 sq.ft. of lot area and to modify applicable dimensional regulations; and

WHEREAS, a public hearing was held on March 21, 2025; and

WHEREAS, by letter dated March 12, 2025, the Suffolk County Planning Commission considered the proposed local law to be a matter for local determination; and

Upon motion made by Tom Mullen, seconded by Sally Beatty and unanimously carried, it was RESOLVED that a request from the Quogue Association to utilize the Village Green for a concert on June 20, 2025 from 5:30 PM until 7:00 PM, to utilize the Village Beach for their annual beach party on Friday, July 18, 2025, from 6:00 PM until 9:00 PM, and to utilize the Village Dock for the Duck Race on August 8, 2025 from 6:00 PM until 8:00 PM is approved.

Upon motion made by Sally Beatty, seconded by Tom Mullen and unanimously carried, it was RESOLVED that a Special Event Permit application from Tim Seymour for a party to be held at the Village Beach on August 23, 2025 from 6:00 PM until 11:00 PM is approved.

Upon motion made by Tom Mullen, seconded by Sally Beatty and unanimously carried, it was RESOLVED that a charity bike-a-thon is permitted to pass through Quogue on September 27, 2025 from 7:45 AM until 1:45 PM.

Upon motion made by Ted Necarsulmer, seconded by Sally Beatty and unanimously carried, it was RESOLVED that the beach pavilion concession is awarded to Zachary Schmidt for the 2025 summer season.

Upon motion made by Tom Mullen, seconded by Sally Beatty and unanimously carried, it was RESOLVED that the Mayor is authorized to issue a Proclamation declaring April 25, 2025 to be Arbor Day in the Village of Quogue.

The Mayor presented the draft budget. He explained that expenses are continuing to increase including pension, fire, and police expenses and commented on the difficulty to keep under the tax cap.

There were no question or comments and upon motion made by Sally Beatty, seconded by Tom Mullen and unanimously carried, it was RESOLVED that a public hearing is scheduled at 3 PM on April 22, 2025 on the tentative budget.

Upon motion made by Tom Mullen, seconded by Sally Beatty and unanimously carried, it was RESOLVED that a special meeting of the Board of Trustees is scheduled for 10 AM on April 24, 2025 for the purpose of adopting the 2025-2026 budget.

The Mayor stated that he wanted to acknowledge the service of Joe Jahelka as an alternate crossing guard for approximately 14 years. Joe submitted his resignation and voluntary retirement letter today, effective this day. Joe has been a longstanding member of the fire department and continues as a member of the fire police. Upon motion made by Sally Beatty, seconded by Tom Mullen and unanimously carried, Joe Jahelka's letter of resignation is accepted and on behalf of the trustees the Mayor expressed the Village's deep appreciation for his many years of service to the Village both as an alternate school crossing guard and member of the fire department.

With no other business to discuss and upon motion made by Sally Beatty seconded by Tom Mullen and unanimously carried, the meeting was adjourned at 4:03 PM.
